LINDA C. SURMACZ ANNUAL ACHIEVEMENT AWARD

This award was established to recognize excellence in team effort between handlers and their retriever.

ELIGIBILITY

- Open to all FSRC Members and their retrievers in good standing.
- This award recognized the team effort by a Handler and Retriever.
- Points will be awarded for each passing/qualifying run in AKC sanctioned events as well as for participation as a worker for all FSRC events held during the 'fiscal' year.

FISCAL YEAR

- Points must be earned from August 1 through July 31.
- Application is attached here and is available from Review Committee members. Deadline for submission of completed is September 1st, of each year.

REVIEW COMMITTEE

- The committee shall consist of three (3) FSRC members in good standing.
- Selection of committee members will be made during the FSRC Spring General Membership Meeting.
- Selection of Review Committee Members should, as best practice, be made with consideration of knowledge of, and/or participation in, various AKC performance venues, i.e. Retriever Field/Hunt Tests, Obedience, Rally, Agility, Dock Diving, Scent Work, K9 Good Citizen, etc.

SCORING OF RETRIEVER POINTS

One (1) point will be awarded for each "Pass" or "Qualifying" performance with the exception of Field Trials. Those points will be awarded to all dogs placing 1st through 4th in any AKC sanctioned Field Trial.

WORKER POINTS

- As indicated above, "worker points" will be awarded to each handler that works as part of the team effort of an FSRC sanctioned event.
 - Only FSRC "worker points" will be considered.
 - One point will be earned for each event worked regardless of the number of days worked.
- An event will be considered "worked" and one (1) point will be awarded if the member helps with event related tasks in the 7 days preceding or the 7 days following an FSRC event.
- Worker points will only be awarded for events listed on the application! "Late" or "Add-On" dates **WILL NOT** be considered.

ENTERING AN APPLICATION IS MADE WITH THE UNDERSTANDING THAT THE DECISION OF THE REVIEW COMMITTEE IS FINAL. ACCEPTANCE OF THE BRONZE AWARD TROPHY IS DONE WITH THE FULL UNDERSTANDING THAT IT IS TO BE RETURNED TO FSRC FOR PRESENTATION TO THE RECIPIENT OF THE AWARD THE FOLLOWING YEAR.
